

DAVIS COUNTY ORDINANCE NO.10

TITLE: VOTING PRECINCT ORDINANCE FOR DAVIS COUNTY, IOWA

Be it enacted by the Board of Supervisors of Davis County, Iowa:

SECTION 1. Purpose. The purpose of this ordinance is to establish voting precincts for Davis County, Iowa as required by Chapter 49.4, Code of Iowa.

SECTION 2. Definitions. For use in this ordinance, the following terms or words shall be interpreted or defined as follows:

1. "Voting Precinct" or "Precinct" shall mean a county or municipal sub-division for casting and counting votes in elections.
2. "Township" shall mean a civil and political subdivision of the county.

SECTION 3. Boundaries of Voting Precincts. Davis County shall have eight (8) voting precincts, in addition to an absentee voting precinct as required by law, whose boundaries shall be as follows:

BLOOMFIELD WARD #1--Eastern portion of incorporated city of Bloomfield as set forth in Ordinance prepared by City.

BLOOMFIELD WARD #2--Northwestern portion of incorporated city of Bloomfield as set forth in Ordinance prepared by City.

BLOOMFIELD WARD #3--Southern portion of incorporated city of Bloomfield as set forth in Ordinance prepared by City.

NORTHWEST PRECINCT --The incorporated City of Drakesville, Drakesville Township, Marion Township and Soap Creek Township.

NORTHEAST PRECINCT --The incorporated city of Floris, Lick Creek Township and Salt Creek Township.

SOUTHEAST PRECINCT --The incorporated City of Pulaski, Grove Township, Prairie Township, Roscoe Township and Union Township.

CENTRAL PRECINCT --Cleveland Township, Perry Township and Wyacondah Township.

SOUTHWEST PRECINCT--Fabius Township , Fox River Township and West Grove Township.

SECTION 4. Repealer. All other ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 5. Severability Clause. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any part thereof not adjudged invalid or unconstitutional.

SECTION 6. When Effective. This ordinance shall be in effect after its final passage, approval, and publication as provided by law, with said new precinct boundaries becoming effective Tuesday, January 15, 2002.
