The Davis County Board of Supervisors met in regular session on Monday, September 4, 2018, with Chairman Matt Greiner and Members Ron Bride and Alan Yahnke present.

Bloomfield Mayor Dan Wiegand spoke with the Board about various community issues during public comment time.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

The Board met with custodian Randy Norman, who reported that the elevator inspector is scheduled to be here this Friday.

The Board met with Engineer Ryan Schock, who reported on bridge projects, including notification that the Nuthatch Avenue bridge is now open. Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to sign utility permit for Rod Veatch.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve second reading of Ordinance #27 regarding assessment of wind energy conversion property, copy of which is available in the Auditor's Office.

The Board met with Sherri Thordarson and discussed scheduling and duties of dispatchers.

The Board met with Main Street Director Tammy Roberts; after discussion Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to permit use of the courtyard for various events on September 29, October 3, November 10 and December 8.
