The Davis County Board of Supervisors met in regular session on Monday, August 27, 2018, with Chairman Matt Greiner and Members Ron Bride and Alan Yahnke present.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, with Matt Greiner abstaining due to his absence last week, to approve and sign the Minutes of Monday, August 20, 2018.

The Board met with custodian Randy Norman, who reported that the elevator repairs are nearly completed, with inspection scheduled for September 7.

The Board met with Engineer Ryan Schock, who reported on Nuthatch bridge progress. Alan Yahnke made motions, seconded by Ron Bride and carried unanimously, to sign utility permit for Citizens Mutual Telephone Company, to sign two utility permits for Southern Iowa Electric Coop, and to sign utility permit for Riley Kleopfer. Ron Bride made motions, seconded by Alan Yahnke and carried unanimously, to sign utility permit for Mediacom, and to sign utility permit for Keith Sullivan.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve first reading of Davis County Ordinance #27 regarding assessment of wind energy conversion property, copy of which is on file in the Auditor's Office.

After discussion, Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, that budgeted funds for the Welcome Center be allocated for interior maintenance as requested by Welcome Center representatives last week.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve beer license for Davis County Agricultural Society for an event on September 26, 2018.

The Board met with Chief Deputy Josh O'Dell and discussed increase in salary for jailers and adding an additional jailer position. Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve beginning wage of \$14.50 per hour, with an increase of \$3.00 per hour after the probationary period, to begin with the next pay period.

Discussion of courthouse Christmas lights was tabled.

All Board members reported on committee meetings attended.

VA Director Terry Bradley informed the Board that SIEDA has no more funding for general assistance.
