The Davis County Board of Supervisors met in regular session on Monday, October 24, 2016, with Chairman Matt Greiner and Members Dale Taylor and Ron Bride present.

Dale Taylor made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

The Board met with custodian Randy Norman, who reported the new door at the VA building has been installed; also he is purchasing a new ice melt treatment for use on the courthouse steps this winter.

The Board met with Secondary Roads and received report on Apple Avenue bridge project; Pearl Avenue bridge will be opened today; and Mulberry Avenue bridge bids were opened last week at state DOT. Contractor bond for striping project was signed by the chairman.

Discussion was held concerning payment to Secondary Roads for fuel used by the Supervisors and the County Assessor; no action taken.

After discussion, Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to sign request to amend watershed improvement project.

The Board met with Eileen Taylor of the Welcome Center, who requested a letter of support for a community grant for sidewalks; Dale Taylor made motion, seconded by Ron Bride and carried unanimously, to prepare a support letter.

The Board met with Megan Clyman, who reported that 22 employees had sign up for the wellness program at Mutchler Center.

Ron Bride reported on South Central Behavioral Health and Mutchler Community Center meetings, and Dale Taylor reported on Davis County Public Health meeting.
