Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

The Board met with Doran Houk, who presented a proposal from the Izaak Walton Chapter for a new shooting range which could be used by law enforcement, the school, and the public. Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to commit the support of the Board for this project.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, October 15, 2018.

The Board met with custodian Randy Norman, who told the Board that he has shut off outside water and repaired windows at the VA building. Discussion was held concerning courthouse Christmas lights.
