The Davis County Board of Supervisors met in regular session on Monday, November 13, 2017, with Chairman Ron Bride and Members Matt Greiner and Alan Yahnke present.

The Board listened to comments from four members of the public.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, November 6, 2017.

The Board met with custodian Randy Norman, who asked about putting motion lights in the vaults and replacing shrubs on the east side of the courthouse.

The Board met with Engineer Ryan Schock, who reported that he had discovered a \$300,000 shortfall mistake on federal aid payback for the Bunch Road; the crack seal project was completed Friday; and striping projects will be finished this week, weather permitting.

Discussion was held concerning Christmas light displays in the courtyard; individual offices will be approached about volunteering to assist.

The Board met with Roger Shindell and Lorna Hecker of Carosh Compliance Solutions and discussed possible sanctions to be included in the HIPAA policy being prepared for the County.

During committee reports, Matt Greiner reported on meetings of the AEA Board, the Senior Center, and Workforce Development. Alan Yahnke reported on meeting of Pathfinders RC & D.

The Board reconvened at 3:00 p.m. to canvass the votes from the November 7, 2017, city elections in Drakesville, Floris, and Pulaski. There were no changes from the unofficial results previously reported.
