The Davis County Board of Supervisors met in regular session on Monday, December 11, 2017, with Chairman Ron Bride and Members Matt Greiner and Alan Yahnke present.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, December 4, 2017.

The Board met with custodian Randy Norman; general discussion, no action taken.

The Board met with Engineer Ryan Schock, who reported on bridge projects. Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to sign utility permit for Rathbun Rural Water Association.

The Board met with John Schroeder, who requested use of the courtyard for a breakfast on June 23, 2018, for Hairy Nation Days, and for a pancake breakfast on July 4, 2018, for Rotary Club. Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve same.
