The Davis County Board of Supervisors met in regular session on Monday, January 22, 2018, with Chairman Matt Greiner and Members Ron Bride and Alan Yahnke present.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, January 15, 2018.

The Board met with custodian Randy Norman and discussed tree removal in courtyard and other minor maintenance issues.

The Board met with Engineer Ryan Schock, who reported on a change in road salt vendor and gave update on progress of Robin Boulevard bridge. He also presented a proposed dirt road upgrade policy for the Board to review. Bids were received for the Hougland box culvert, with Bloomfield Bridge & Culvert being the low bidder.

The Board met with Sarah Leer and Warren Halverson, who invited the Board to attend an open house on February 20 to tour an energy efficient passive house.

The Board met with Lois Abel-Priester and Roger Wuthrich, who presented public library budget information for fiscal year 2019, and requested that the County contribute \$41,398 for library funding.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve Resolution for Financial Support of Area 15 Regional Planning Commission, in the amount of \$.47 per capita, for a total amount of \$2,599.57 for operating costs from July 1, 2018, through June 30, 2019.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the Treasurer's semi-annual report.

During committee reports, Matt Greiner reported on meetings of AHEAD Housing, Davis County Hospital Board, and Public Safety Commission; Alan Yahnke reported on meeting of Local Emergency Planning; and Ron Bride reported on meetings of Bloomfield Main Street and ISAC University.

The Board reconvened at 1:45 p.m. to review office budgets with Auditor Linda Humphrey.
