The Davis County Board of Supervisors met in regular session on Monday, February 11, 2019, with Chairman Alan Yahnke and Member Ron Bride present.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, February 4, 2019. Mayor Dan Wiegand spoke during public comments about the housing incentive proposal previously mentioned to the Board.

The meeting with custodian Randy Norman was cancelled.

The Board met with Engineer Ryan Schock, who reported that crews were out salting and sanding roads from Tuesday afternoon through Friday. After discussion, Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to sign federal aid agreement for Beechwood Avenue bridge. Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve revision of the 2019 Five-year Road Program for the addition of applying rock on one road per blading region.

At 10:00 a.m. bids were opened for the County Farm lease. High bid was received from Hillview Angus at \$68.80 per acre and Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to sign a contract in accord with that bid.

The Board met with Mayor Dan Wiegand and discussed what could be done to keep the Shopko store from leaving Bloomfield, including a joint agreement concerning taxes.

The Board met with Sheriff Dave Davis and discussed overtime pay and his budget.

At 1:00 p.m. the Board reconvened for staff meeting.
