The Davis County Board of Supervisors met in regular session on Tuesday, February 21, 2017, with Chairman Ron Bride and Members Matt Greiner and Alan Yahnke present.

During public comments, Leon Wilkinson updated the Board on a Mormon Trail meeting he recently attended.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Thursday, February 9, 2017.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, February 13, 2017.

The Board met with custodian Randy Norman and discussed general courthouse issues.

The Board met with Secondary Roads: Assistant Engineer Ryan Schock reported on bridge projects and application for milled-in-striping on six roads. He is reviewing quotes for crack sealing.

The Board met with Susan Haskell and Devon Pitlick to request use of the courtyard on May 6, 2017, for the Walk for Life event. Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve same.

After discussion, Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to transfer two tax sale certificates to the City of Floris after payment of the full amount of back taxes.

After discussion, Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to transfer six tax sale certificates to Lincoln Lynch after payment of the full amount of back taxes through March, 2017.

After discussion, Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to transfer tax sale certificate to John Hilbert upon payment of back taxes in the amount of \$1,746.25.

After discussion of MJ's Countryscape proposal for fertilizer and pesticide treatment for the courtyard, Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to not apply this spring but revisit for fall application.

The Board met with John Hansen, who reported that final inspection on the new jail will be next week, followed by fire inspection. There will be an open house for the public on March 11, 2017. Hansen presented change orders and Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the following: Engineering and architect, \$6,000; handcuff bench, \$1,288; construction management fee, \$3,200; plumbing fixtures, \$13,283.77; Winger's for sprinkler, \$1,726. Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve the following change orders: Woodruff, \$29,331; HVAC grills and ducts, \$680; VanMaanen for security, \$26,319.23.

The Board reconvened at 1:00 to review office budgets with Auditor Linda Humphrey.
