The Davis County Board of Supervisors met in regular session on Monday, April 30, 2018, with Chairman Matt Greiner and Members Ron Bride and Alan Yahnke present.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, April 23, 2018. Matt Greiner abstained as he was not present last week.

The Board met with Engineer Ryan Schock, who reported on bridge projects and grant approval from DOT for signs.

The Board met with Assessor Lois Heckethorn, who presented applications for Forest Reserve exemptions for approval. Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve all applications as submitted.

Discussion was held with the Assistant County Attorney concerning a possible wind energy policy for the county; policies and ordinances from other jurisdictions were considered; no action taken.

During committee reports, Ron Bride reported on meetings of South Central Behavioral Health Region and Chariton Valley Transportation Planning; Alan Yahnke reported on meetings of Pioneer Cemetery Commission, 10-15 Transit Authority, SIRG, and Davis County Historical Preservation Committee; and Matt Greiner reported on meetings of Fox River Watershed, Area XV Regional Planning Commission, and Davis County Senior Citizens Committee.
