The Davis County Board of Supervisors met in regular session on Monday, May 21, 2018, with Chairman Matt Greiner and Members Ron Bride and Alan Yahnke present.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

The Board met with custodian Randy Norman, who reported on an accident to the drop box in the driveway and his plan to repair the box.

The Board met with Engineer Ryan Schock, who reported that the Oxen Trail bridge was opened last week and that the DOT can do a speed limit engineering study on Jaguar Trail at no cost to the county. Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to sign utility permit for Northeast Missouri Power.

Discussion was again held regarding concerns to be addressed if a decision is made to approve a regulatory wind energy ordinance; no action taken.
