The Davis County Board of Supervisors met in regular session on Tuesday, May 30, 2017, with Chairman Ron Bride and Members Matt Greiner and Alan Yahnke present.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve and sign the Minutes of Monday, May 22, 2017.

The Board met with custodian Randy Norman, who updated the Board concerning tree trimming and problems with the flagpole light.

The Board met with Engineer Ryan Schock, who reported that the Mulberry bridge will be opened later this week and the Fig Avenue bridge may also be opened this week. The Board was requested to sign bond for crack sealing project and to sign Farm-to-Market expense sheet concerning the airport road bridge.

After discussion with Assistant County Attorney Ashley Leyda Walkup, Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to rescind approval of the previous lease with the City of Bloomfield for the Davis County Law Center which was signed in February 2017. Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve the revised lease presented by the Assistant County Attorney.

Matt Greiner made motion, seconded by Alan Yahnke and, by roll call vote with all members voting "aye", carried unanimously, to approve the following Resolution: Motion to repay the temporary loan of \$100,000 made in September of 2016 from the General Supplemental Fund to the Rural Basic Fund, back into the General Supplemental Fund from the Rural Basic Fund. Said loan was made to cover operating expenses in the Rural Basic Fund.

During committee reports, Matt Greiner reported on SIEDA meeting and possible sale of lot in Ottumwa, and Area XV meeting. Alan Yahnke reported on 10/15 Transit meeting and LEPC meeting.
