The Davis County Board of Supervisors met in regular session on Monday, August 7, 2017, with Chairman Ron Bride and Members Matt Greiner and Alan Yahnke present.

During public comments, Nancy Clancy spoke about parking spaces, Ron Wilson and Ted Miller spoke concerning bridge problems.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, July 31, 2017.

The Board met with custodian Randy Norman; general discussion, no action taken.

The Board met with Engineer Ryan Schock; after discussion, Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to present prepared contract to the Engineer for his approval. Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to sign utility permit for Southern Iowa Electric; Matt Greiner also made motion, seconded by Alan Yahnke and carried unanimously, to sign contracts for safety shouldering project. The Board listened to comments from the public concerning the previous closure of Fawn Avenue; Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to have the County Attorney investigate the possibility of reversing the closure of Fawn Avenue.

The Board met with Tom Prosapio, who reported that he is putting together a scope of work to come up with a budget for roof and gutter upgrades to the courthouse.

Discussion was held concerning the possibility of selling land that is part of the County Home property; no action taken.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to remove the name of Debra Bailey from Treasurer's Office bank accounts and replace with Amber White.

After discussion, Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to table the proposed resolution concerning parking next to the courtyard.
