The Davis County Board of Supervisors met in regular session on Monday, August 20, 2018, with Members Ron Bride and Alan Yahnke present.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

The Board met with custodian Randy Norman, who reported that the elevator repair is nearing completion but will have to be inspected before use.

The Board met with Engineer Ryan Schock, who presented right-of-way papers and contract with BRS Construction for signature; Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to sign utility permits for Rathbun Regional Water Association.

The Board met with Diane Bales, Carol Birchmier, and Judy Combs, who requested that budgeted funds for the Welcome Center be allocated for interior maintenance. Further discussion and possible approval will be addressed at next Monday's meeting.

The Board met with Sheriff Dave Davis by phone and Chief Deputy Josh O'Dell to discuss jailer positions. One jailer has resigned due to low pay and Sheriff Davis would like to increase the pay and hire an additional jailer.
