The Davis County Board of Supervisors met in regular session on Monday, September 17, 2018, with Chairman Matt Greiner and Members Ron Bride and Alan Yahnke present. During public comments, Bloomfield Mayor Dan Wiegand told the Board that demolition of the oil jail will begin Thursday.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, September 10, 2018.

The Board met with custodian Randy Norman, who told the Board that electrical work on the elevator will resume on Tuesday, with inspection still set for September 25.

The Board met with Engineer Ryan Schock, who reported that he has not yet received all signatures required for an easement with West Grove Township for maintenance equipment parking. He also reported on progress of bridge projects and requested a list of auction items to be provided to the auctioneer for the October 16 auction.

The Board met with Chief Deputy Josh O'Dell, who said the Izaak Walton League is interested in creating a shooting range to be used both for themselves and city and county law enforcement.

At 10:00 Chairman Greiner opened hearing concerning Davis County Ordinance #27 . After discussion, with no public comment, Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to close the hearing. First reading of proposed ordinance was read. Ron Bride then made motion, seconded by Alan Yahnke and carried unanimously, to pass Davis County Ordinance #27 regarding assessment of wind energy conversion property.

Matt Greiner will meet with All American Turf & Beauty on September 26 to assess the possibility of additional Christmas lights on the courthouse.

All Board members reported on committee meetings attended.
