Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve the agenda, with notation that meeting with Megan Clyman is cancelled. There were no public comments.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, April 8, 2019.

The Board met with custodian Randy Norman and discussed purchase of replacement tree for Farmer's Market area of courtyard. Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to purchase one tree.

The Board met with Engineer Ryan Schock, who reported that bridge removal is beginning today at the Vaughn Proctor project; contracts will be signed with Douds Stone and Crane Quarries for purchase of rock; after discussion, Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve utility permit for Rathbun Rural Water Association.
