The Davis County Board of Supervisors met in regular session on Monday, May 20, 2019, with Chairman Alan Yahnke and Members Matt Greiner and Ron Bride present.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve and sign the Minutes of Monday, May 6, 2019, and Monday, May 13, 2019.

Discussion was held concerning fuel tracking capabilities at Secondary Roads. Fire Chief Jeff McClure expressed interest in moving fuel purchasing for the fire department to Secondary Roads for better tracking, and Engineer Ryan Schock will set this up for them.

The Board met with custodian Randy Norman, who reported that the main floor of the courthouse was re-waxed over the weekend, and the new light for the flagpole was installed.

The Board met with Engineer Ryan Schock, who reported on progress of bridge projects and assessments for various methods to repair or extend the life of roads in the county. Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve utility permit for Southern Iowa Electric. Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve a temporary road closure for Floris Flag day celebration and to provide signage for Floris officials to pick up. After discussion, the Board opted to not pass a noxious weed control resolution.

The Board discussed with the County Attorney a possible ordinance regarding RAGBRAI vendors; and it was his opinion that an ordinance similar to that of the City of Bloomfield, with a few wording changes, would be appropriate. Ron Bride made motion, seconded by Matt Greiner and carried unanimously, to approve publication of such an ordinance after preparation by the County Attorney and final review by the Board.

All Board members reported on committee meetings attended.
