The Davis County Board of Supervisors met in regular session on Tuesday, May 28, 2019, with Chairman Alan Yahnke and Member Matt Greiner present.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, May 20, 2019.

The Board met with custodian Randy Norman, who told the Board that the boiler inspection was last week and the system was approved. He also said that the LED bulb replacements in the courtyard lamps was completed.

The Board met with Engineer Ryan Schock, who reported that it has been too wet to work on the bridge projects; he presented an amendment to revise the 2020 Five-year Program and Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve same. The Chairman also signed the FY2019 budget amendment for the Department of Transportation.

First reading of Ordinance #28 was held. The proposed ordinance concerning RAGBRAI vendors was previously published in *The Bloomfield Democrat* on May 22, 2019, and copies are available in the Auditor's Office. Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the ordinance as read. Matt Greiner also made motion, seconded by Alan Yahnke and carried unanimously, to waive the second and third readings of the ordinance.

At 10:00 a.m. the Board held hearing concerning Fiscal Year 2020 budget. There being no public comments, Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to close the hearing. Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the budget as previously published in *The Bloomfield Democrat* on May 15, 2019.

At 10:15 a.m. the Board held hearing on Amendment to Fiscal Year 2019 budget. There being no public comments, Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to close the hearing. Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the amended budget as previously published in *The Bloomfield Democrat* on May 15, 2019.
