The Davis County Board of Supervisors met in regular session on Tuesday, September 3, 2019, with Chairman Alan Yahnke and Members Matt Greiner and Ron Bride present.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, August 26, 2019.

The Board met with custodian Randy Norman, who reported that courthouse water line shut-offs have been checked and repaired. He also mentioned that after the Meet the Mustangs event, there were electrical box covers removed and drain pipes moved.

The Board met with Engineer Ryan Schock and was informed that work continues on the Beechwood bridge, patching on Lilac Avenue starts this week, and the Ware tank car is coming this Thursday.

After discussion, the Assistant County Attorney was asked to prepare a tanning bed ordinance for first reading next week.
