The Davis County Board of Supervisors met in regular session on Monday, January 27, 2020, with Chairman Ron Bride and Members Matt Greiner and Alan Yahnke present.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, January 20, and Thursday, January 23, 2020.

The Board met with custodian Randy Norman, who explained that the boiler issues of the past week have been resolved with new parts.

The Board met with Engineer Ryan Schock, who reported that snow removal equipment was out Thursday, Friday, Saturday, and Sunday. He also updated the Board on Janssen bridge progress and bid amounts for the Jade Avenue bridge.
