The Davis County Board of Supervisors met in regular session on Monday, April 13, 2020, with Chairman Ron Bride and Members Matt Greiner and Alan Yahnke present.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve and sign the Minutes of Monday, April 6, 2020.

The Board met with custodian Randy Norman, with him reporting that it will be necessary to replace a defective Heat/AC unit in one of the rooms in the Courthouse.

The Board met with Engineer Ryan Schock, who noted that the “Goodson” bridge should be finished and open by May 1st. He also stated that a crack sealing process will be started soon on the Bunch Road and on Eagle Blvd., and that a gap filling material will be used on the Floris Road, within the city limits of Floris, and also repairs to the work done last fall on the road East of Drakesville.

At 10:00 a.m. the Chairman called budget amendment hearing to order. There being no public comments, Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to close the hearing. Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the budget amendment as previously published in *The Bloomfield Democrat* on April 1, 2020.
