The Davis County Board of Supervisors met in regular session on Monday, April 6, 2020, with Chairman Ron Bride and Members Matt Greiner and Alan Yahnke present.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve and sign the Minutes of Monday, March 23, 2020.

During public comments, Davis County Auditor, Linda Humphrey, discussed with the Supervisors and they agreed that the Veterans Affairs Director would continue working from home, until further notice.

The meeting scheduled with the courthouse custodian was cancelled.

The Board met with Engineer Ryan Schock and opened bids for the 2020 rock program. Bids were received from three companies regarding ten projects. Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to accept the lowest bid on each item, pending the County Engineer's approval. Low bids were received from Douds Stone, Crane Quarries, and Cantera Aggregates.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the annual contract with the auditing firm of Anderson, Larkin & Co., P.C., of Ottumwa, Iowa.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the appointment of Debbie Jarr as the County HIPAA Privacy Officer.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously to approve the Quarterly income reports from the Auditor, Recorder, and Treasurer.
