The Davis County Board of Supervisors met in regular session on Tuesday, May 26, 2020, with Chairman Ron Bride and Members Alan Yahnke and Matt Greiner present.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, May 18, 2020.

The Board met with custodian Randy Norman, and discussed general maintenance.

The Board met with Engineer Ryan Schock, who reported that the newly replaced Janssen bridge is now open. The asphalt crack sealing project for the fairgrounds road, that was supposed to be completed last week, has been delayed due to rainy weather.

The Board met with Chief Deputy Josh Sinnott, and after discussion, Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to appoint two medical examiner death investigators, Josh Sinnott and Teri Hanna, after certification, to assist the county medical examiner.

The Board met with Kirby Moss and Ryan White, from Acumen Advisors, to discuss the County self-funded insurance renewal. No action was taken.

All Board members reported on committee meetings attended. Alan Yahnke reported that the Davis County Fair meeting he attended resulted in the decision to cancel both the fair, and the 4th of July rodeo for this summer, due to Covid-19 precautionary recommendations.
