Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, August 17, 2020.

The Board met with custodian Randy Norman, who reported that the drain mapping, performed by Roto-Rooter Sewer & Drain Cleaning, as research for the accessibility planning, has been completed.

The Board met with Engineer Ryan Schock, and discussed a possible road closure of a portion of Pike Blvd., among other county projects.
