The Davis County Board of Supervisors met in regular session on Tuesday, September 8, 2020, with Members Alan Yahnke and Matt Greiner present. Chairman Ron Bride was absent.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve the agenda.

There were no comments from the public.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve and sign the Minutes of Monday, August 31, 2020.

The Board met with custodian Randy Norman, who reported on ceiling repairs done at the Veterans Affairs/DHS building on South Madison Street.

The Board met with Engineer Ryan Schock, who reported on current regular road maintenance. Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve setting a public hearing, regarding a road/bridge closure, on a portion of Pike Blvd., for September 28th at 9:00 A.M. Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve a utility permit to Southern Iowa Electric Coop., Inc., at a location on 140th St.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve and sign a 3-year management agreement with Optima LifeServices.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve the hiring of Megan Price for a position in the Recorder's Office.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the decision from the Veterans Affairs Commission to pay Veterans Affairs Director Tisha Scott for additional temporary hours in September.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve a resolution establishing a provision for sick leave covering essential employees, where an absence is required due to reasons specified in the Family First Coronavirus Response Act (FFCRA), and the employee does not have enough leave accrued.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve a resolution requesting reimbursement for eligible costs related to the COVID-19 public health emergency from the Iowa COVID-19 Government Relief Fund.

Present Board members reported on committee meetings attended.

The Board met with Michael Nolan of Horizon Architecture and others, via internet, for continued discussion regarding the plan for courthouse accessibility improvement.
