The Davis County Board of Supervisors met in regular session on Monday, November 16, 2020, with Chairman Ron Bride and Members Alan Yahnke and Matt Greiner present.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve and sign the Minutes of Monday, November 9, 2020.

The Board met with custodian Randy Norman, who reported on general building maintenance issues.

The Board met with Engineer Ryan Schock, who informed the Board about on-going road and bridge projects within the county. He reported that the Alpine Avenue bridge project was now completed and there will be crack sealing repairs started today on Ice Avenue, North and South of Drakesville.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the estimate for multiple plumbing and drain repairs to be made at the Davis Center/Optimae facility in the amount of \$5,149.44.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve moving the insurance renewal date for both Principal Life and Delta Vision to the beginning of the Fiscal Year which is July 1 of each year.

The Board discussed a request from the Judicial Branch to install audio/visual conferencing equipment in the courthouse courtroom, but tabled any action until more information can be obtained.

Alan Yahnke made motion, seconded by Matt Greiner and carried unanimously, to approve sending a letter of request for funding, to the Davis County Courthouse Preservation Fund, for a contribution to the current project of improving accessibility to the courthouse.

All Board members reported on committee meetings attended.
