The Davis County Board of Supervisors met in regular session on Monday, December 21, 2020, with Chairman Ron Bride and Members Alan Yahnke and Matt Greiner present.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

No public comments were made.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, December 14, 2020.

The Board met with custodian Randy Norman, who discussed general courthouse maintenance items.

The Board met with Engineer Ryan Schock, who reported that the county crews are blading, hauling rock, and doing some ditch cleaning. They will also be doing some blacktop patching this week, and with weather permitting, the bridge crews will be continuing to work on the Mahogany Avenue bridge and the Jade Avenue bridge projects.

The Board discussed a tax abatement inquiry for the West Grove Crossroads Church, but there was no action taken.

The Board discussed a possible increase to the Employee Health Plan premiums for the next fiscal year, but decided to table taking action until more review is completed.

The Board met with Sheriff Dave Davis and Chief Deputy Josh Sinnott who presented an arrangement of increased duties, and respective salary adjustment, to be made to the position of Assistant Jail Administrator.

Matt Greiner made motion, seconded by Alan Yahnke and carried unanimously, to approve a temporary job modification, due to a personal matter, for the Veterans Affairs Director. After an initial 2 weeks, Director Tisha Scott will be working from home for a period of 4 weeks, at which time the matter will be revisited.
