The Davis County Board of Supervisors met in regular session on Monday, January 18, 2021, with Chairman Matt Greiner and Members Alan Yahnke and Ron Bride present.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, January 11, 2021.

The Board met with custodian Randy Norman, who reported that he had tested the boilers and only required a fuse to be changed in one. He is also working on replacing some ceiling tiles in the courtroom.

The Board met with the Assistant to the Engineer Bret Davis, who reported that the bridge on Mahogany is ready for concrete to be poured, which will unfortunately need to wait until the weather warms up.

The Board met with Jackie White and Fran Harris, representing the West Grove Crossroads Church in West Grove. They presented a petition to the Board requesting a tax abatement be approved for said church. The total tax amount owed is approximately \$2,700.00. Jackie White stated that they have filed for Tax Exempt status, going forward, with the State of Iowa.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve that any current and unpaid past taxes, interest, fees and/or other costs, be abated for the West Grove Crossroads Church.

The Board reviewed 3 recommendations given by IMWCA (Iowa Municipalities Workers Compensation Association) for minimalizing workers compensation claims and maintaining a safe workplace. They will be taking actions on those recommendations in future meetings.

All Board members reported on committee meetings attended.

The Board returned after a lunch break to review departmental budgets with County Auditor Linda Humphrey, in preparation for approval of overall County budget. This process will continue at the next meeting.
