The Davis County Board of Supervisors met in regular session on Monday, August 15, 2016, with Chairman Matt Greiner and Members Dale Taylor and Ron Bride present.

During public comments Ken Wuthrich, Nancy Clancy, Ernie Bohi, Lyn Davidson, Ken Turner, Doug Dixon, Mike Fitzgerald, Jake Bohi, Chris Ball, Megan Clyman and Rick Davidson spoke about the streetscape project, indicating concerns with the historical status of the square and changes in highway lane numbers; and commenting on possible accessibility improvements due to the plan.

Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, August 8, 2016. Dale Taylor abstained due to his absence last week.

The Board met with Secondary Roads; crews hauled 1,174 tons of rock last week; bid letting for the Bunch road paving project is tomorrow on the state level; and usual mowing and blading continue. Request for farm to market designation for the road to the quarry was denied. Road striping in certain areas will begin in September.

After discussion of recent IMWCA findings, the report was given to Secondary Roads for their consideration.

Discussion was held concerning SIEDA lease and necessary weapons ordinance; the County Attorney suggested the proposed ordinance be put on the agenda for next week's Board meeting.

The Board met with Jason Cooper of the streetscape design team, City Council member Earl Howard, and Chris Ball, chairman of the City's streetscape committee. Presentation was made to the Board outlining various aspects of the plan and its impact on the courthouse and courtyard; consensus was to work on a compromise; no action taken.

At 1:00 p.m., the Board reconvened ; Matt Greiner made motion to go into closed session according to Iowa Code Section 21.5(i) to discuss applications for custodian position and Ron Bride seconded, with roll call vote indicating Ron Bride "aye", Dale Taylor "aye", and Matt Greiner "aye", motion passed. After discussion, Ron Bride made motion to come out of closed session and Dale Taylor seconded, with roll call vote indicating Ron Bride "aye", Dale Taylor "aye", and Matt Greiner "aye", motion passed. After returning to open session, Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to offer the custodial position to an applicant for his consideration, with final approval by the Board at a later date.
