The Davis County Board of Supervisors met in regular session on Monday, February 29, 2016, with Chairman Matt Greiner and Members Dale Taylor and Ron Bride present.

During public comment time, Lonnie Archer had questions about road funding and Ken Turner commented concerning the county's termination of membership with RUSS.

Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to approve the agenda.

Dale Taylor made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, February 22, and Thursday, February 25, 2016.

The Board met with Secondary Roads; work continues on the airport bridge, the Polkey bridge, and Acorn bridge.

The Board met with Megan Clyman of the Historical Preservation Commission.; after discussion Dale Taylor made motion, seconded by Ron Bride and carried unanimously, to re-appoint Judy Combs and Jesse Bonner to terms ending April 5, 2018, and to re-appoint Chris McClure and Megan Clyman to terms ending April 5, 2019.

Ray Boas was recognized by the Chairman, and asked the Board if there was any way that he could pay for some gravel because he has been tracking mud onto the road; he was told of the gravel purchase program put in place by the County. Butch Hale was recognized by the Chairman and asked questions concerning upgrades to Monarch Trail.

The Board opened sealed bids for the County Farm lease; the high bid was received from Grim Farms, LLC, in the amount of \$115.00 per acre, being a total of \$35,279.70. Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to award the lease to Grim Farms, LLC.

Ron Bride reported that ISAC has posted a study concerning each county's financial status.
