June 13, 2016 Bloomfield, Iowa Boardroom-Courthouse 8:30 A.M.

The Davis County Board of Supervisors met in regular session on Monday, June 13, 2016, with Chairman Matt Greiner and Members Dale Taylor and Ron Bride present.

During public comments a number of citizens spoke about problems they perceived with a possible change from 4 lanes to 3 lanes of traffic on the east side of the square. Those attending were: Joy Evans, Ken Wuthrich, Roger Wuthrich, Al Wettstein, Joel Wuthrich, Jacob Bohi, Matt Wettstein, Chip Grant, and Ken Turner.

Dale Taylor made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Matt Greiner made motion, seconded by Dale Taylor and carried unanimously, to approve and sign the Minutes of Monday, June 6, 2016; Ron Bride abstained due to absence last week.

The Board met with Secondary Roads; the Engineer reported that the airport road bridge project is complete. The only bid for the City of Floris bridge replacement project was from Bloomfield Bridge & Culvert for \$93,578.50; Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to accept the bid contingent on verification of calculations. Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to set July 11, 2016, at 9:00 a.m. as the letting date for Apple Avenue bridge.

The Board met with Trent Gregory of Citizens Mutual Telephone concerning permits for telephone fiber cable replacement under Umber Avenue; Ron Bride made motion, seconded by Dale Taylor and carried unanimously, to approve the permits.

Matt Greiner made motion, seconded by Ron Bride, to approve beer license for Bloomfield Speedway, covering a one-night event at the fair; Dale Taylor opposed, motion carried.

Lynnette Singley of Iowa Department of Natural Resources spoke to the Board about Project Aware, being volunteer cleanup of a portion of the Des Moines River during the week of July 11-15, with a kick-off educational meeting and dinner at Eldon. Volunteers are needed.

As a result of earlier discussions of the Bloomfield Streetscape plan and highway lane changes, a countywide survey was taken. Matt Greiner reported that the results were considered not valid as, contrary to instructions, multiple votes were cast from individual computer IP addresses. There were only 428 IP addresses, but 2591 responses. Therefore, when the excess votes were removed and only one vote was counted from each IP address, the results changed from 78% in favor of 3 lanes to 78% in favor of remaining 4 lanes.

The Board reconvened at 3:00 to canvass votes from the June 7, 2016, primary election. There were no changes, and results were as follows:
